INSTRUCTIONS FOR COMPLETING OUT-OF-STATE TITLE TRANSFER

1. Complete and mail the *Request for Release of Title from Lienholder* form and mail it to your lienholder.
2. Contact your preferred title office after ten business days to ensure we have received your title.
3. Obtain a physical inspection of the vehicle from your local license bureau or a car dealership. The physical inspection is a verification of the vehicle description (i.e., year, make and serial number). The inspection fee is \$5.00 (\$3.50 cost to the inspection station and \$1.50 cost to the title office). You will receive an inspection certificate which will expire thirty days from issuance. *The inspection certificate is needed to complete your title transaction.*
4. All applications require the signature of each owner who is listed on the out-of-state title.
5. The original Ohio Certificate of Title will be mailed directly to the lienholder. A Memorandum Certificate of Title can be issued to you for the purpose of obtaining Ohio license plates at your license bureau.
